

GBP Balanced Active Fund

This fund update was first made publicly available on 28 July 2020.

What is the purpose of this update?

This document tells you how the GBP Balanced Active Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited (Lifetime) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

Great British Pound denominated fund that seeks to generate modest capital growth over the medium to long-term and return above the rate of inflation. The fund will be invested in an actively managed and diversified portfolio of equity, fixed income, absolute return, property and commodity investments at various parts of the economic cycle. Seeks to track a composite index (before annual fund charge and tax), comprising 50% MSCI World (net dividends) (LCT) and 50% Bloomberg Barclays Global Aggregate Bond Index (GBP hedged)

What are the risks of investing?

Risk indicator for the GBP Balanced Active Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

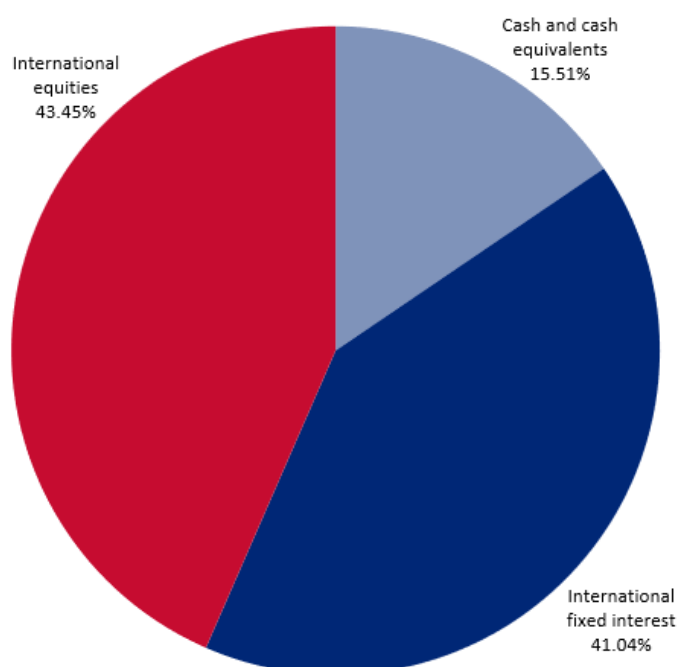
Example of how this applies to an investor

Ben had £10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of -£28 (that is -0.28% of his initial £10,000). Ben also paid £0 in other charges. This gives Ben a total return after tax of -£38 for the year.

What does the fund invest in?

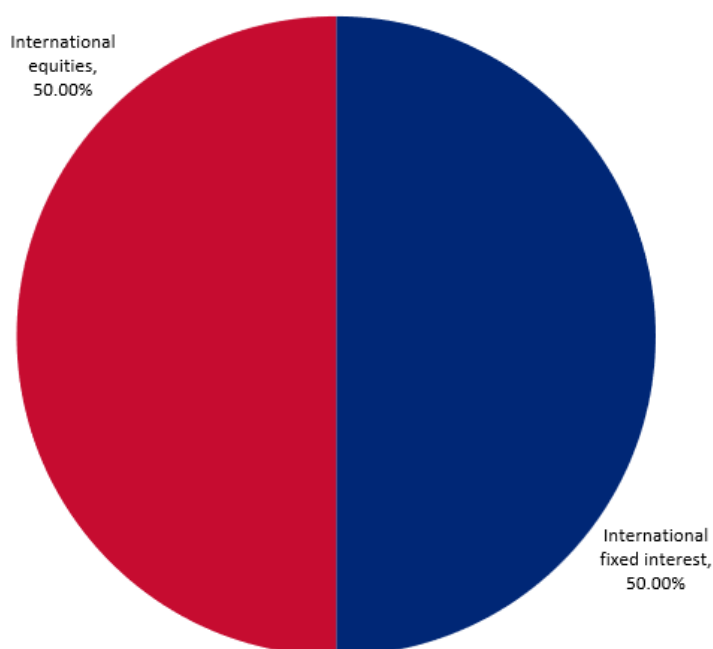
Actual investment mix

Currency hedging

The base currency of the fund is Great British pounds. No currency hedging is performed at the fund level and the fund is not hedged to New Zealand dollars. The underlying funds invest in international securities and are not hedged back to Great British pounds by the investment manager of the underlying funds.
