GBP Growth Active Fund



This fund update was updated on 14 January 2021.

This fund update replaces the fund update first made publicly available on 29 October 2020 to update the section headed "How has the fund performed?" to include a corrected market Index annual return.

What is the purpose of this update?

This document tells you how the GBP Growth Active Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited (Lifetime) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

Great British Pound (GBP) denominated fund that seeks to generate capital growth over the medium to long-term. The Fund will invest in an actively managed and diversified portfolio of equity, fixed income, absolute return, property, alternative and commodity investments at various parts of the economic cycle. Seeks to track a composite index (before annual fund charge and tax), comprising 70% MSCI World (net dividends) (LCT) and 30% Bloomberg Barclays Global Aggregate Bond Index (GBP hedged).

What are the risks of investing?

Risk indicator for the GBP Growth Active Fund


Example of how this applies to an investor

Ben had £10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of £37 (that is 0.37% of his initial £10,000). Ben also paid £0 in other charges. This gives Ben a total return after tax of £18 for the year.


Actual investment mix
