# **GBP Growth Fund**

### What is the purpose of this update?


# **Description of this Fund**

Great British Pound denominated fund employing an active asset allocation strategy and a passive investment management strategy invested 15% in income assets (international fixed interest), with 85% exposure to growth assets (listed property and international equities). Seeks to track composite indices (before annual fund charge and tax), comprising 15% Bloomberg Global Aggregate Corporate Index 100% hedged to GBP, 7% FTSE EPRA/NAREIT UK Property Index and 78% MSCI world ESG Screened Index Net GBP.

### What are the risks of investing?

### Risk indicator for the GBP Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Investors may also be charged individual action fees for specific actions or decisions. For example, during the period to 31 March 2022, the funds strategic asset allocations were formally reviewed and amended to increase the Scheme's exposure to investments that recognise the importance of environment, social and corporate governance (ESG). The costs of rebalancing the portfolio in 2022 has been deducted from the scheme. See the PDS for more information about those fees.

# Example of how this applies to an investor

Ben had £10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of -£1,060 (that is -10.60% of his initial £10,000). Ben also paid £0 in other charges. This gives Ben a total return after tax of -£1,154 for the year.


### **Actual investment mix**

### **Currency hedging**

The base currency of the Fund is GBP and the base currency of the underlying funds Is United States dollars. No currency hedging is performed at the fund level and the fund is not hedged to New Zealand dollars. The underlying funds invest in international securities and are hedged back to United States dollars by the investment manager of the underlying funds. The currency hedging is passive, meaning the investment manager of the underlying funds target the benchmark hedging level (i.e. 100%), although actual hedging may differ from this, due to cash flow and market movements.

Lifetime has made reasonable endeavours to obtain all relevant information regarding currency hedging, but due to a lack of information (i.e. the underlying investment manager does not publish foreign hedging levels) Lifetime is not able to report the foreign hedging level of the Underlying Funds.
