# **AUD Balanced Fund**

This fund update was first made publicly available on 3 May 2023.

#### What is the purpose of this update?

This document tells you how the AUD Balanced Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited (Lifetime) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this Fund**

Australian Dollar denominated fund employing an active asset allocation strategy and a passive investment management strategy invested 40% in income assets (international fixed interest), with 60% exposure to growth assets (Australasian and international equities). Seeks to track composite indices (before annual fund charge and tax), comprising 20% Bloomberg Aus Bond Credit 0+ Yr Index, 20% Bloomberg Global Treasury Scaled Index 100% hedged to AUD, 20% FTSE Australia 300 Choice Index and 40% MSCI World ex Australia Custom ESG Leaders Index 100% hedged to AUD.

# Risk indicator for the AUD Balanced Fund




# Example of how this applies to an investor

Ben had AUD \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of AUD -\$735 (that is -7.35% of his initial AUD \$10,000). Ben also paid AUD \$0 in other charges. This gives Ben a total return after tax of AUD -\$834 for the year.


# **Actual investment mix**

## **Currency hedging**

The base currency of the Fund and underlying funds is Australian dollars. No currency hedging is performed at the fund level and the Fund is not hedged to New Zealand dollars. The underlying funds invest in international securities and are 100% hedged back to Australian dollars by the investment manager of the underlying funds.

Lifetime has made reasonable endeavours to obtain all relevant information regarding currency hedging, but due to a lack of information (i.e. the underlying investment manager does not publish foreign hedging levels) Lifetime is not able to report the foreign hedging level of the underlying funds.
