SuperLife Age Steps - Age 40

This is a replacement investment update dated 3 July 2025, which replaces the previous investment update dated 1 May 2025. The actual investment mix pie chart in the “What does the stage invest in?” section has been updated to show corrected asset allocation data for the period.

Investment update for the quarter ended 31 March 2025

This investment update was first made publicly available on 3 July 2025.

What is the purpose of this update?

This document tells you how SuperLife Age Steps - Age 40 (the stage) has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this stage

SuperLife Age Steps automatically sets the proportion of your investment in income and growth assets based on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife Age Steps - Age 40 investment will be allocated 20.8% to income assets and 79.2% to growth assets.

What are the risks of investing?

Risk indicator for SuperLife Age Steps - Age 40



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the stage performed?

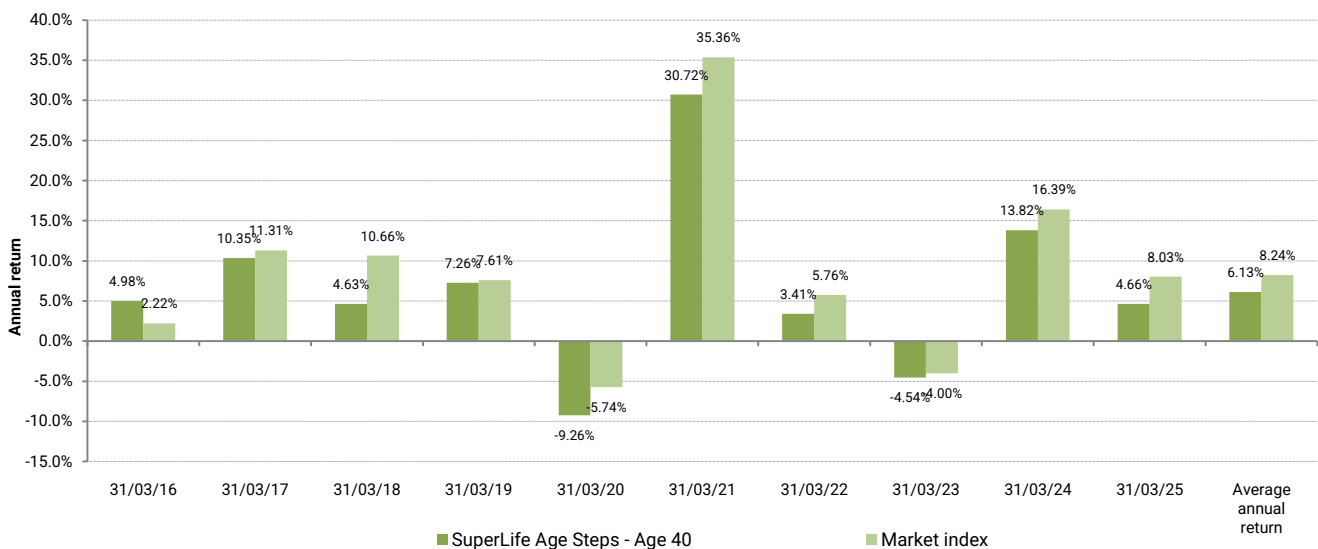

Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2025.

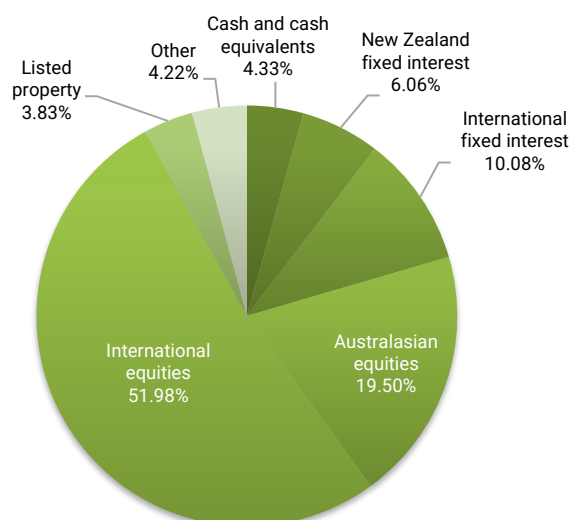
Example of how this applies to an investor

Jess had \$10,000 in the stage at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$564 (that is 5.64% of Jess's initial \$10,000). Jess also paid \$60 in other charges. This gives Jess a total return after tax of \$406 for the year.

Notes

- 1 The fund charges for SuperLife Age Steps are estimates based on the target investment mix of underlying funds for each age step. The fund charges actually charged may differ from the estimate if the actual investment mix of underlying funds for your investment differs from the target because of market movements.
- 2 These charges refer to the normal stage operating costs that are charged to the stage. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the stage.
- 3 The 'other' category refers to an investment in infrastructure. The underlying investments are infrastructure securities listed in developed countries.
