### GBP Growth Fund

#### What is the purpose of this update?

This document tells you how the GBP Growth Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited (**Lifetime**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

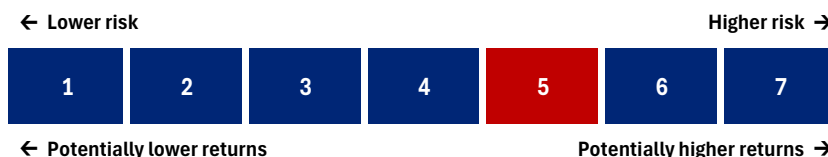
#### Description of this Fund

Great British Pound denominated fund employing an active asset allocation strategy and a passive investment management strategy invested 15% in income assets (international fixed interest), with 85% exposure to growth assets (listed property and international equities). The Fund seeks to track composite indices (before annual fund charge and tax). The Fund is expected to experience high volatility.

#### What are the risks of investing?

##### Risk indicator for the GBP Growth Fund

## How has the Fund performed?

The market index annual return for the Fund is a composite index, calculated using the return of each asset class index the Fund invests in, weighted by the Fund's benchmark asset allocation.

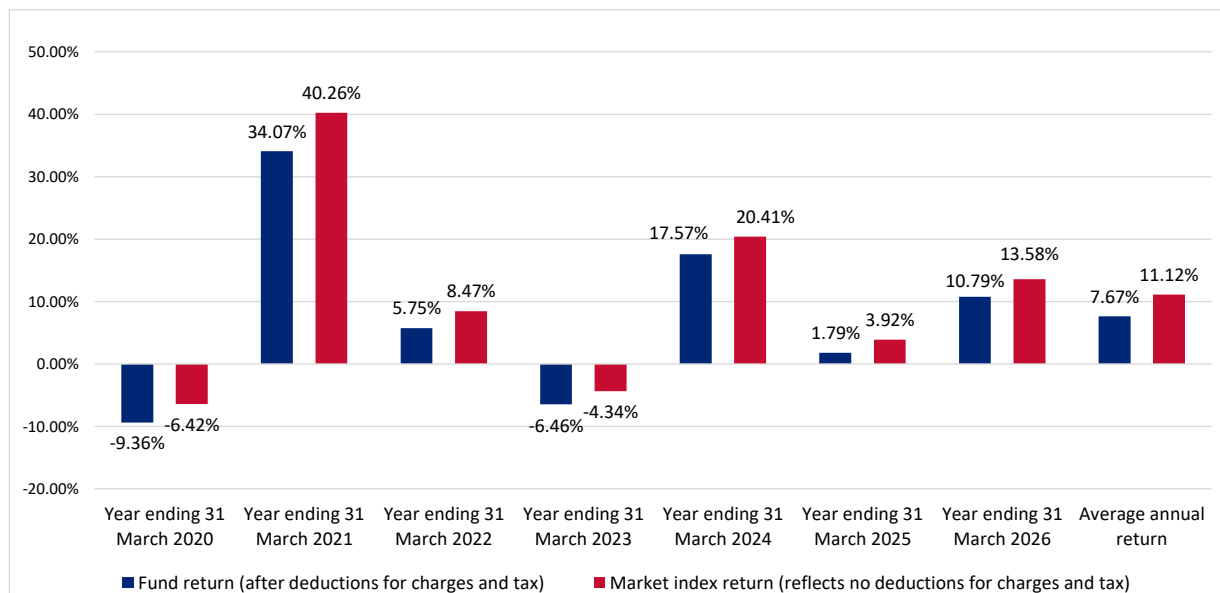

Small differences in fees and charges can have a big impact on your investment over the long term.

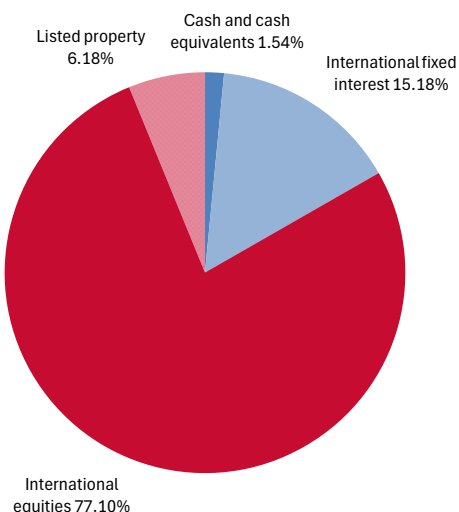
### Example of how this applies to an investor

Ben had £10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of £1,204 (that is 12.04% of his initial £10,000). Ben also paid £0 in other charges. This gives Ben a total return after tax of £1,079 for the year.

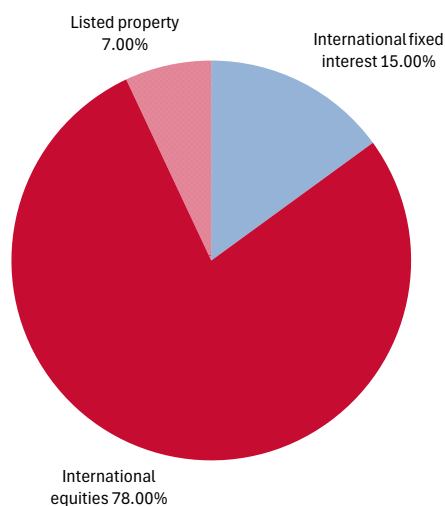
### Actual investment mix

## Currency hedging

The base currency of the fund is Great British Pounds and the base currency of the underlying global funds that provide exposure to international fixed interest and international equities is United States Dollars. No currency hedging is performed at the fund level and the fund is not hedged to New Zealand Dollars. The following foreign currency exposure targets will apply to international assets:

- International fixed interest – 100% hedged to Great British Pounds.
- International equities – 100% unhedged to Great British Pounds.

The currency hedging is passive, meaning the investment manager of the underlying funds target the benchmark hedging level, although actual hedging may differ from this, due to cash flow and market movements.
